This warranty is valid for **■R**.CARBONAT **Welle** Sinus, Trapez 76/18 and Sinus 177/51, in 0,5 - 3,0 mm thickness, in colors clear, bronze, opal white und klima grey.

Warranty statement

We provide a warranty for **R.CARBONAT** Welle like follows:

0,5 - 0,7 mm thickness:
5 years on breakage through hailstones measuring up to 20 mm diameter
0,8 - 1,1 mm thickness:
10 years on breakage through hailstones measuring up to 30 mm diameter
1,2 - 2,4 mm thickness:
10 years on breakage through hailstones measuring up to 40 mm diameter

2,5 - 3,0 mm thickness: 10 years on breakage through hailstones unlimited

0,5 - 0,7 mm thickness: 5 years on yellowing

(Change of less than 10 units deltaE in case of clear sheets and 15 deltaE

in case of colored sheets in comparison to virgin new sheets) 5 years on light transmission (change of less than 10% in

comparison to virgin new sheets)

0,8 - 3,0 mm thickness: 10 years on yellowing

(Change of less than 10 units deltaE in case of clear sheets and 15 deltaE

in case of colored sheets in comparison to virgin new sheets) 10 years on light transmission (change of less than 10% in

comparison to virgin new sheets)

The light transmission values are mentioned in our technical datasheet for **R.CARBONAT** Welle.

Breakage by hailstones to this warranty is achieved, if during a hailstone-simulation ice-balls of 20 - 40 mm, depending on sheet thickness like above, are shot on the weathered sheet at room temperature.

Warranty conditions

The sheets

- have to be correctly stored, transported, treated and installed (used),
- are not mechanical damaged / scratched at the surface,
- should not be thermal formed,
- · are not allowed to be (negative) influenced by connecting-, fixing- and sealing-elements
- have to be protected against negative chemical influence.

This warranty is valid in all countries in Europe. Any demand for warranty outside Europe, please contact us.

Case of Warranty

A complaint in accordance with this warranty is accepted,

- if it turns out during the warranty-period and all warranty-conditions are properly documented,
- · if written notice is given immediate within the warranty-period and
